## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SCOTT FEWEL 64302 W COATS RD PROSSER WA 99350

confirms the right to use the waters of A WELL in the HAT ROCK DRAIN (COLUMBIA RIVER) for IRRIGATION of 29.9 ACRES AND SUPPLEMENTAL IRRIGATION of 46.3 ACRES.

This right was perfected under Permit G-6041. The date of priority is FEBRUARY 20, 1974. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.95 cubic feet per second, if available at the original well, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH, of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The combined quantity of water diverted at the new point of appropriation (well), together with the quantity diverted at the old point of appropriation, shall not exceed the quantity of water lawfully authorized by the water right described as follows:

When required by the Department, the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department and shall be installed under the general supervision of the Department.

Water shall be acquired from the same aquifer as the original point of appropriation.

This certificate is issued to confirm a change in THE POINT OF APPROPRIATION approved by an order of the Water Resources Director entered DECEMBER 2, 2002, at Special Order Volume 56, Page 2138, approving Transfer Application 8910, and together with Certificate 79693, supersedes Certificate 53387, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
