confirms the right to use the waters of WELL #A, within the UMATILLA RIVER BASIN for IRRIGATION of 7.6 ACRES.

This right was perfected under Permit G-2782. The date of priority is FEBRUARY 4, 1965. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.095 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Water shall be acquired from the same aquifer as the original point of appropriation. The well must be maintained so as not to penetrate the underlying basalts.

The well shall be maintained in accordance with the General Standards for the construction and Maintenance of Water Wells in Oregon.

This certificate is issued to confirm a change in the POINT OF APPROPRIATION approved by an order of the Water Resources Director entered March 16, 2011, at Special Order Volume 83, Page 821, approving Transfer Application T-8901, and supercedes Certificate 72145, State record of Water Right Certificates.
