## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CLYDE HOLLIDAY FAMILY RANCHES INC. 62394 HWY 26 JOHN DAY OR 97845

confirms the right to use the waters of PINE CREEK, tributary to JOHN DAY RIVER for IRRIGATION of 252.8 ACRES.

This right was perfected under Permit 49885. The date of priority is NOVEMBER 7, 1986. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 6.38 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point(s) of diversion.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484 and ORS 536.075. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 183.484, ORS 536.075 and OAR 137-004-0080, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in place of use and additional points of diversion approved by an order of the Water Resources Director, entered April 7, 2006, at Special Order Volume 68, Page 257, approving Transfer Application 7438, and together with Certificate 81964, supersedes Certificate 80463, State record of Water Right Certificates.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
