This right was perfected under Permit S-17511. The date of priority is MAY 21, 1947. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 50 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point(s) of diversion.
