CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DAVID DITCHEN
7385 HOWELL PRAIRIE RD
SILVERTON, OR 97381

confirms the right to use the waters of ZABRANSKY WELLS 1, 2 AND 3 within the STAGE GULCH BASIN for PRIMARY IRRIGATION of 1.37 ACRES AND SUPPLEMENTAL IRRIGATION of 907.51 ACRES.

This right was perfected under Permit G-8209. The date of priority is FEBRUARY 27, 1978. This right is limited to not more than 9.523 CUBIC FEET PER SECOND (cfs), being 1.276 CFS from WELL 1, 3.338 CFS from WELL 2, and 4.909 CFS from WELL 3; or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 ACRE-FEET per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
