confirms the right to use the waters of FIVE WELLS within the UMATILLA RIVER BASIN for PRIMARY IRRIGATION of 1.8 ACRES AND SUPPLEMENTAL IRRIGATION of 45.0 ACRES.

This right was perfected under Permit G-10452. The date of priority is JUNE 13, 1983. This right is limited to not more than 0.58 CUBIC FOOT PER SECOND; being 0.17 CFS from WELL 1 when available with any deficiency in the available supply from Well 1 to be made up by appropriation from WELLS 2, 3, 4, and 5; 0.08 CFS from WELL 3 to be made up by appropriation from WELLS 2, 4, and 5; 0.23 CFS from WELL 2 when available with any deficiency in the available supply from Well 2 to be made up by appropriation from WELLS 1, 3, 4, and 5; and 0.10 CFS from WELL 5 when available with any deficiency in the available supply from Well 5 to be made up by appropriation from WELLS 1, 2, 3, and 4, or its equivalent in case of rotation, measured at the wells.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 ACRE-FEET per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right existing for the same land an shall not exceed the limitation allowed herein. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
