Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 183.482, ORS 536.075 and OAR 137-004-0080 you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

confirms the right to use the waters of FIFTEENMILE CREEK, a tributary of the COLUMBIA RIVER for IRRIGATION OF 9.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for WASCO COUNTY. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 7 at page 406. The date of priority is 1860.

The points of diversion (POD) are located as follows:

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 3.0 acre-feet per acre irrigated in any irrigation season of each year.

A description of the place of use is as follows:

This certificate is issued to describe changes in points of diversion and place of use approved by orders of the Water Resources Director entered January 14, 1966, at Special Order Volume 14, Page 411, approving Transfer C-163; November 10, 1977, at Special Order Volume 30, Page 44, approving Transfer Application 3704; and March 5, 1986, at Special Order Volume 40, Page 59, approving Transfer Application 5691, and together with Certificate 87350 supersedes Certificate 5612.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
