CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of FIFTEENMILE CREEK, a tributary of the COLUMBIA RIVER for IRRIGATION OF 3.2 ACRES.

This right was perfected under Permit 30646. The date of priority is JULY 12, 1965. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.04 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The points of diversion (POD) are located as follows:

1	1 S	13 E	WM	26	SW SW	1470 FEET NORTH AND 1250 FEET EAST FROM SW CORNER, NW 1/4 NW 1/4, SECTION 35
2	1 S	13 E	WM	35	NW NW	1280 FEET NORTH AND 750 FEET EAST FROM SW CORNER, NW 1/4 NW 1/4, SECTION 35

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

A description of the place of use as follows:

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This certificate describes that portion of the water right confirmed by Certificate 37474, State Record of Water Right certificates, NOT modified by the provisions of orders of the Water Resources Director entered November 10, 1977, at Special Order Volume 30, Page 46, approving Transfer Application 3705; and March 5, 1986, at Special Order Volume 40, Page 59, approving Transfer Application 5691, and supersedes Certificate 37474.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
