Pursuant to ORS 183.482, ORS 536.075 and OAR 137-004-0080 you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
