CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

J. J. MURPHY  
ASHLAND, OR

confirms the right to use the waters of Walker Creek, a tributary to Bear Creek for the purpose of IRRIGATION of 10.0 ACRES and DOMESTIC USE for TRACT NO. 1; and IRRIGATION of 42.20 ACRES, SUPPLEMENTAL IRRIGATION OF 0.57 ACRE, AND DOMESTIC AND STOCK USE for TRACT NO. 2.

This right was confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 4, at page 1. The date of priority is 1878 for Tract No. 1, 1860 for Tract No. 2.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.2 cubic foot per second for Tract No. 1, and 0.537 cubic foot per second for Tract No. 2.

A description of the place of use to which this right is appurtenant is as follows:


This certificate is issued to correct scrivener's errors in Certificate 87109. This Certificate Supersedes Certificate 87109, and describes the portion of water right Certificate 87109 NOT modified by the provisions of an order of the Water Resources Director entered August 23, 2011k, and recorded at Volume 85, Pages 253-259, approving Transfer Application T-10043, and cancelling and diminishing a portion of Certificate 87109.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within 60 days of the date of service.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
