CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WAYNE R. FRIZZELL
SUMMERSVILLE, OR 97876

confirms the right to use the waters of LEWIS BRANCH for IRRIGATION of 7.0 ACRES in TRACT 1 and MOUNTAIN STREAMS for IRRIGATION of 13.0 ACRES in TRACT 2.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Union County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 7, at Page 227. The dates of priority are 1906 for TRACT 1 and 1893 for TRACT 2.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 ACRE- FEET per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes that portion of the water right confirmed by Certificate 33244, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered **JAN 20 2012**, and recorded in Special Order Volume 85, Pages 941 to 944, approving Transfer Application T-10500. This certificate also describes that portion of Certificate 33244 NOT CANCELLED by Final Order in Contested Case OWRD Case No. PC 06-09 (OAH Ref. No: WR-11-004) entered January 13, 2012, and recorded in Special Order Volume 85, Pages 921 to 929. This certificate together with Certificate 87388 supersedes Certificate 33244.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
