A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of FIFTEENMILE CREEK, a tributary of the COLUMBIA RIVER for IRRIGATION OF 29.2 ACRES.

This right was perfected under Permit 42252. The date of priority is JUNE 13, 1977. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.37 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located as follows:

1 S	13 E	WM	26	SW SW	1470 FEET NORTH AND 1250 FEET EAST FROM SW CORNER, NW 1/4 NW 1/4, SECTION 35

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

A description of the place of use is as follows:

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This certificate describes that portion of the water right confirmed by Certificate 50114, State Record of Water Right certificates, NOT modified by the provisions of an order of the Water Resources Director entered MARCH 5, 1986, at Special Order Volume 40, Page 59, approving Transfer 5691, and supersedes Certificate 50114.

THIS CERTIFICATE IS ISSUED TO CORRECTLY IDENTIFY THE LOCATION OF THE PLACE OF USE AND SUPERSEDES CERTIFICATE 87356.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
