CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GRANDE RONDE VALLEY IRRIGATION CO.
205 MAIN AVE
LA GRANDE, OR 97850

confirms the right to use the waters of GEKELER SLOUGH (sometimes called Mill Creek), a tributary to the GRANDE RONDE RIVER for SUPPLEMENTAL IRRIGATION of 979.2 ACRES.

This right was perfected under Permit S-22904. The date of priority is NOVEMBER 24, 1953. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 9.93 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate is issued to correct a scrivener's error in the total number of acres described on Certificate 84714. This Certificate supersedes Certificate 84714, and describes the portion of water right Certificate 85112, NOT modified by the provisions of an order of the Water Resources Director entered February 3, 2012, and recorded at Volume 87, Page 30, approving Transfer Application T-11306 and partially cancelling this right.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
