This certificate is issued approving ADDITIONAL POINTS OF APPRROPRIATION approved by an order of the Water Resources Director entered April 4, 2003, at Special Order Volume 57, Page 326, approving Transfer Application 9301, and supersedes Certificate 50606, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described; however, water may be applied to lands which are not specifically described above, provided the holder of this right complies with ORS 540.510(3).
