confirms the right to use the waters of APPLEGATE RIVER, tributary to ROGUE RIVER for IRRIGATION of 3.9 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Josephine County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 16, at Page 523. The date of priority is FEBRUARY 1899. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.082 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The types and plans of the measuring device must be approved by the Department prior to beginning construction and that the weir or measuring device be installed under the general supervision of the Department.

This certificate is issued to confirm a change in place of use approved by an order of the Water Resources Director entered May 27, 1987, at Special Order Volume 41, Page 231, approving Transfer Application 5926, and together with Certificate 56348, supersedes Certificate 32888, State record of Water Right Certificates.

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
