CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GALE MERWIN

PAULINA OR 97751

confirms the right to use the waters of WATSON CREEK AND MERWIN RESERVOIR NO. 2, CONSTRUCTED UNDER PERMIT R-3258, a tributary of Crooked River, for IRRIGATION of 273.1 ACRES AND SUPPLEMENTAL IRRIGATION of 302.8 ACRES.

This right was perfected under Permit S-28800. The date of priority is AUGUST 6, 1962. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 7.20 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion (POD) are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-3258.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.
