confirms the right to use the waters of WELL WW-1794 AND WELL WW-1800, tributaries to the COLUMBIA RIVER for DOMESTIC, POWERHOUSE AND GENERAL USE, BONNEVILLE PROJECT.

This right was perfected under Permit G-3156. The date of priority is JUNE 13, 1966. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.43 CUBIC FOOT PER SECOND (CFS), being 0.10 cfs for domestic, 0.10 for powerhouse, and 0.23 cfs for general use, or its equivalent in case of rotation, measured at the wells.
