This right was perfected under Permit G-5001. The date of priority is MAY 5, 1972. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 19.8 CUBIC FEET PER SECOND, in any combination, or its equivalent in case of rotation, measured at the wells.
