confirms the right to use the waters of the McKAY CREEK, a tributary of the UMATILLA RIVER, for IRRIGATION OF 138.99 ACRES.

This right was perfected under Permit 1540. The date of priority is JANUARY 3, 1912. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.73 CUBIC FEET PER SECOND if available at the original point of diversion from the source.

The point of diversion is located as follows:

The right to the use of the water for any purpose is restricted to the lands or place of use herein described, and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
