CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL, tributary to UMATILLA RIVER for IRRIGATION of 9.8 ACRES.

This right was perfected under Permit G-7358. The date of priority is May 22, 1972. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.11 cubic foot per second, or its equivalent in case of rotation, measured at the well, AND IS FURTHER LIMITED TO NOT MORE THAN 9.8 ACREFEET PER MONTH DURING THE IRRIGATION SEASON, TO A MAXIMUM OF 29.4 ACRE-FEET PER SEASON.

The quantity of water appropriated shall not exceed the quantity of water available at the old well located as follows: 200 FEET NORTH AND 30 FEET EAST FROM THE CENTER OF SECTION 7, WITHIN THE SW ¼ NE ¼, TOWNSHIP 4 NORTH, RANGE 28 EAST, W.M. (WADEKAMPER WELL).

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
