confirms the right to use the waters of WELLS 1, 1A, 1B, AND 2A, tributaries to PUDDING RIVER for IRRIGATION of 96.2 ACRES.

This right was perfected under Permit G-164. The date of priority is MARCH 14, 1956. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.64 CUBIC FOOT PER SECOND, in any combination, or its equivalent in case of rotation, measured at the wells.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
