## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WELLS 1, 1A, 1B, AND 2A, tributaries to PUDDING RIVER for IRRIGATION of 132.8 ACRES.

This right was perfected under Permit G-7720. The date of priority is APRIL 8, 1977. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.56 CUBIC FEET PER SECOND, in any combination, or its equivalent in case of rotation, measured at the wells.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This certificate is issued to confirm a change in point of appropriation and adding points of appropriation approved by an order of the Water Resources Director entered June 10, 1994, at Special Order Volume 48, Page 206, approving Transfer Application 6448, and together with Certificate 68381, supersedes Certificate 53546, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
