CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of APPLEGATE RIVER, tributary to ROGUE RIVER for IRRIGATION of 1.0 ACRES AND SUPPLEMENTAL IRRIGATION of 2.0 ACRES.

This right was perfected under Permit 3743. The date of priority is MARCH 25, 1918. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.038 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated from April 2, to October 31, of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered January 10, 1991, at Special Order Volume 45, Page 19, approving Transfer Application 5984, and together with Certificate 65145, supersedes Certificate 56324, State record of Water Right Certificates.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
