CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RON DECONINCK 6381 DECONINCK RD NE WOODBURN OR 97071

confirms the right to use the waters of WELL 2 AND WELL 3, tributaries to WILLAMETTE RIVER for IRRIGATION of 232.4 ACRES AND SUPPLEMENTAL IRRIGATION OF 175.6 ACRES.

This right was perfected under Permit G-2487. The date of priority is JULY 10, 1963. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.68 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the wells.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This certificate is issued to confirm an additional point of appropriation approved by an order of the Water Resources Director entered October 26, 1992, at Special Order Volume 46, Page 478, approving Transfer Application 6484, and supersedes Certificate 36299, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
