## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CUNNINGHAM SHEEP CO PO BOX 1186 PENDLETON OR 97801

confirms the right to use the waters of UMATILLA RIVER, tributary to COLUMBIA RIVER for IRRIGATION of 7.0 ACRES.

This right was confirmed by a decree of the Circuit Court of the State of Oregon for Umatilla County dated September 9, 1916. The decree is of record at Salem, in the Order Record of the Water Resources Director and the right is tabulated at Volume 3, at Page 240. The date of priority is 1902.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.09 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the points of diversion.

The points of diversion are located as follows:

The water user shall maintain an in-line flow meter, a weir, or other suitable measuring device.

This certificate is issued to confirm a portion of an Additional Point of Diversion approved by an order of the Water Resources Director entered August 10, 1981, at Special Order Volume 35, Page 88, approving Transfer Application 4763 and together with Certificate XXXXX, describes the rights modified under Transfer Application 4763.

## NOTICE OF RIGHT TO RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
