CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BLAINE GRASSMAN 12783 RIVER RD NE GERVAIS OR 97026

confirms the right to use the waters of TWO WELLS, in the WILLAMETTE RIVER BASIN, for IRRIGATION of 98.6 ACRES.

This right was perfected under Permit G-5187. The date of priority is January 11, 1973 for 0.89 cubic feet per second (cfs), and December 17, 1973 for 0.25 cfs. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.14 cfs; being 1.14 cfs from Well 1 and 0.74 cfs from Well 2 in any combination, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The quantity of water diverted at the new point of appropriation (well), together with that diverted at the old point of appropriation, shall not exceed the quantity of water available from the original point of appropriation.

When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm changes in points of appropriation approved by an order of the Water Resources Director entered October 31, 2006, at Special Order Volume 70, Page 438, approving Transfer Application 8862, and supersedes Certificate 45074, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
