The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source. The specific limits and conditions of use are listed below.

**NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW**

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Measurement, recording and reporting conditions:

- A. The water user shall maintain the staff gage in good working order.
- B. The water user shall allow the watermaster access to the measuring device; provided however, where the measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

The quantity of water diverted at the new point of diversion, shall not exceed the quantity of water lawfully available from the original point of diversion.

The dam shall be operated and maintained consistent with the conditions approved by OWRD for Raevenbrook Reservoir, originally specified in Permit R-11254, as modified below.


The water user shall maintain fish passage consistent with ODFW's Fish Passage Approval document #PA-02-0028.

Flashboards are to be removed no later than October 15 and not installed again until April 15 of each year.

This certificate is issued to confirm a change in POINT OF DIVERSION AND PLACE OF USE approved by an order of the Water Resources Director entered April 5, 2011, at Special Order Volume 82, Page 956, approving Transfer Application 10977, and together with Certificate 86985, supersedes Certificate 83204, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
