## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of the JOHN DAY RIVER for IRRIGATION of 6.5 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Grant County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 15, at Page 461. The date of priority is JUNE 1893. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.16 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH OF ONE CUBIC FOOT PER SECOND PER ACRE IRRIGATED FROM APRIL 1 TO SEPTEMBER 30; FURTHER LIMITED TO ONE ACRE-FOOT PER ACRE PER CALENDAR MONTH TO JULY I AND 3/4 ACRE-FOOT PER ACRE THEREAFTER; TOTAL of FIVE ACRE-FEET PER ACRE PER SEASON.

A description of the place of use is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.

This certificate is issued in accordance with OAR 690-380-6010 to describe the water right for a non-completed change in points of diversion approved by an order of the Water Resources Director entered February 28, 2002, at Special Order Volume 56, Page 74, approving Transfer Application 7507, and together with Certificate 87508, supersedes Certificate 25566, State record of Water Right Certificates.
