CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of TWO WELLS, tributaries to ZOLLNER CREEK for IRRIGATION of 73.0 ACRES.

This right was perfected under Permit G-6733. The date of priority is NOVEMBER 26, 1975. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.67 CUBIC FOOT PER SECOND, in any combination from the wells, or its equivalent in case of rotation, measured at the wells.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The quantity of water diverted at the new point of appropriation (well), together with the quantity of water diverted at the old point of appropriation, shall not exceed the quantity of water lawfully available from the original point of appropriation.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
