## THIS CERTIFICATE ISSUED TO

# STATE OF OREGON WATER RESOURCES DEPARTMENT

confirms the right to use the waters of FIFTEENMILE CREEK, tributary to the COLUMBIA RIVER, for instream use for conservation, maintenance and enhancement of aquatic and fish life, wildlife, fish and wildlife habitat and other ecological values.

This right was perfected under Permit S-5412. The date of priority is NOVEMBER 17, 1921. The amount of water to which this right is entitled is limited to an amount actually beneficially used, and shall not exceed:

Water rights upstream of the original points of diversion shall not be subject to regulation for flows in excess of the quantities to which this instream water right is entitled at the original points of diversion. The original points of diversion are located as follows:

Within the specified stream reach, the amount of water to which this right is entitled shall not exceed the quantity of water legally available at the original points of diversion. Stream channel losses and gains calculated based on available data and the use of water by senior appropriators will determine the amount of water to which this right is entitled downstream from the original points of diversion within the specified stream reach from River Mile 29 to the mouth of Fifteen Mile Creek and whether the described instream flows below River Mile 29 may be adjusted. If adjusted, instream flows from River Mile 29 to the mouth of Fifteen Mile Creek may not exceed the quantities specified within Reach #2.

The instream right established by this transfer shall replace a portion of instream water rights established pursuant to ORS 537.341 or 537.346 and shall be in addition to instream water rights established pursuant to ORS 537.348 or 537.470, unless otherwise specified by a subsequent order establishing a new instream water right.

The right is subject to all other terms and conditions of Certificate 62743, and any related decree.

This certificate is issued to confirm a change in use and place of use approved by an order of the Water Resources Director recorded in Special Order Volume 37, Page 414, approving Transfer T-11272, and supersedes Certificate 62743, State Record of Water Right Certificates.
