 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WASTE MANAGEMENT DISPOSAL SERVICES of OREGON, INC.
 17629 CEDAR SPRINGS LANE
 ARLINGTON, OR 97812

confirms the right to use the waters of TWO WELLS IN THE COLUMBIA RIVER BASIN for IRRIGATION of 1.08 ACRES AND INDUSTRIAL USES AT A SANITARY LANDFILL TO INCLUDE DUST CONTROL, CONSTRUCTION WATERING AND EQUIPMENT WASHDOWN.

This right was perfected under Permit G-10808. The date of priority is MARCH 25, 1988. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 600 GALLONS PER MINUTE (GPM), BEING 6 GPM FOR IRRIGATION AND 594 GPM FOR INDUSTRIAL USE, measured at the wells.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the new point of appropriation (well 6), together with the quantity of diverted at the old points of appropriation (wells 1 & 2), shall not exceed the quantity of water available from the original points of appropriation.


Water shall be acquired from the same aquifer as the original points of appropriation.

The water user shall maintain the in-line flow meters or other measuring devices for the measuring and recording of the quantity of appropriated.

This certificate is issued to confirm an ADDITIONAL POINT OF APPROPRIATION approved by an order of the Water Resources Director entered July 28, 2006, at Special Order Volume 69, Page 224, approving Transfer Application 10063, and supersedes Certificate 64882, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
