CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BERT PESCIALLO
 ROUTE 2, BOX 59
 MILTON-FREEWATER, OR 97862

a right to use the waters of POWELL DITCH WASTE WATER, a tributary of the WALLA WALLA RIVER for the purpose of SUPPLEMENTAL IRRIGATION of 7.7 acres.

This right was perfected under Permit S-51044. The date of priority is JANUARY, 30 1989. The amount of water to which the right is entitled is limited to an amount actually beneficially used and shall not exceed 0.19 cubic foot per second (cfs) or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

6 N	35 E	WM	34	SE SW	835 FEET NORTH AND 228 FEET WEST FROM THE S1/4 CORNER OF SECTION 34

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cfs per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. This right shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall also be limited to the water available at the proposed point of diversion, and shall not carry with it the right to compel the continuance of the waste water.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

A description of the place of use to which this right is appurtenant is as follows:

Failure to comply with any of the provisions of this right may result in action including but not limited to restrictions on the use, civil penalties, or cancellation of the right.


This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

This certificate describes the water right confirmed by Certificate 68686, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered AUG 14 2012, approving a petition by Walla Walla River Irrigation District under ORS 541.329 for mapping water rights within a district. This certificate supersedes Certificate 68686.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
