This is a final order in a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675 you may petition for judicial review and may petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Baker County. The decree is recorded in the Order Record of the Water Resources Director in Volume 11, at Page 235. The date of priority is 1874 for Tract #1 and 1883 for Tract #2.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 40 miners inches for Tract #1; and one fortieth of a cubic foot per second per acre, measured at the point of diversion, and a total limitation of one acre-foot per acre during July, one acre-foot per acre during August, and one-half acre-foot per acre during September, of each year, for Tract #2.
