CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of WELL 3, WELL 4, AND WELL 5, tributaries to BUTTE CREEK BASIN for IRRIGATION OF 69.2 ACRES.

This right was perfected under Permit G-8280. The date of priority is JULY 5, 1978. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.865 CUBIC FOOT PER SECOND (CFS), being 0.310 CFS from Well 3, 0.768 CFS from Well 4, and 0.185 CFS from Well 5, in any combination from the wells, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
