## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

OREGON STATE UNIVERSITY AGRICULTURAL EXPERIMENT STATION FTNL 28645 HWY 34 CORVALLIS OR 97333

confirms the right to use the waters of FOUR WELLS, tributaries to WILLAMETTE RIVER for FISH RESEARCH LABORATORY.

This right was perfected under Permit G-2459. The date of priority is JUNE 28, 1963. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.20 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the wells.

## NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in points of appropriation approved by an order of the Water Resources Director entered September 15, 1995, at Special Order Volume 49, Page 312, approving Transfer Application 6687, and supersedes Certificate 36779, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
