CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of the LAKE OF THE WOODS, a tributary to SELDOM CREEK for DOMESTIC USE FOR ONE FAMILY.

This right was perfected under Permit S-44227. The date of priority is MAY 2, 1979. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.005 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

A description of the place of use to which this right is appurtenant is as follows:

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.

This certificate is issued to correct a scrivener's error in the property lot described in the place of use on Certificate 56350. This Certificate supersedes Certificate 56350, pursuant to the provisions of an order of the Water Resources Director entered July 13 2012, and recorded at Volume 88, Page 109.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
