## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

G AND C FARMS 4196 81ST AV NE SALEM OR 97305

confirms the right to use the waters of WELL 6, WELL 6A, AND WELL G-2303, tributaries to PUDDING RIVER for IRRIGATION OF 61.8 ACRES AND SUPPLEMENTAL IRRIGATION OF 123.5 ACRES.

This right was perfected under Permit G-7720. The date of priority is APRIL 8, 1977. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.74 CUBIC FEET PER SECOND (CFS); BEING 0.70 CFS FROM WELL 6, 1.05 CFS FROM WELL 6A, AND 0.53 CFS FROM WELL G-2302, in any combination, or its equivalent in case of rotation, measured at the wells.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHT1ETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This certificate is issued to confirm a change in points of appropriation and additional points of appropriation approved by an order of the Water Resources Director entered June 10, 1994, at Special Order Volume 48, Page 203, approving Transfer Application 6449, and together with Certificate 68381, supersedes Certificate 53546, State record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
