## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DANIEL J MILLS 41002 RIETH RD PENDLETON OR 97801

confirms the right to use the waters of UMATILLA RIVER, a tributary of the COLUMBIA RIVER for IRRIGATION of 16.41 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 3, at Page 240. The date of priority is JANUARY 4, 1909.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.205 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

A description of the place of use is as follows:

The quantity of water diverted at the new point of diversion shall not exceed the quantity of water lawfully available at the original point of diversion described as follows:

Water shall be acquired from the same surface water source as the original point of diversion.

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable measuring device for measuring and recording the quantity of water diverted.

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered February 18, 1997, at Special Order Volume 51, Page 91, approving Transfer Application 6658, and together with Certificate 74104, supersedes the water right in the name of George R. Roberts evidenced by Decree of the Circuit Court of the State of Oregon for Umatilla County recorded in the Order of Record of the Water Resources Director at Volume 3, at Page 240.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
