CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SAGE HOLLOW RANCH, LLC 3620 INDEPENDENCE RD SUNNYSIDE, WA 98944

confirms the right to use the waters of the COLUMBIA RIVER, a tributary to the PACIFIC OCEAN, for IRRIGATION OF 39.1 ACRES AND SUPPLEMENTAL IRRIGATION of 251.5 ACRES.

This right was perfected under Permit S-45563. The date of priority is FEBRUARY 5, 1981. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.5 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that although declared herein to be for supplemental irrigation in part the right allowed may, in the interest of conserving the ground water supplies be exercised at times when water is available in the ground water supply provided that the total quantity diverted from all sources of supply does not exceed the limitation allowed herein. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
