## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CUNNINGHAM SHEEP CO. PO BOX 1186 PENDLETON OR 97801

confirms the right to use the waters of UMATILLA RIVER, tributary to COLUMBIA RIVER for IRRIGATION of 124.9 ACRES.

This right was confirmed by decrees of the Circuit Court of the State of Oregon for Umatilla County dated September 9, 1916 and September 1, 1961. The decrees are of record at Salem, in the Order Record of the Water Resources Director and the rights are tabulated at Volume 3, at Page 240, and Volume 15, Page 430. The date of priority is 1902.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.01 CUBIC FEET PER SECOND (cfs) FOR THE SEPTEMBER 9, 1916 DECREED LANDS AND 0.55 CFS FOR THE SEPTEMBER 1, 1961 DECREED LANDS, or its equivalent in case of rotation, measured at the points of diversion.

This certificate is issued to correct a scrivener's error and supersedes certificate 87493.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
