CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of ASHLAND CREEK, a tributary to BEAR CREEK for IRRIGATION OF 8.5 ACRES IN TRACT 1; IRRIGATION OF 1.0 ACRE IN TRACT NO. 2; AND IRRIGATION OF 2.3 ACRES AND STOCK USE IN TRACT NO. 3.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 4, at Page 1. The date of priority is 1880 FOR TRACT NO. 1; 1884 FOR TRACT NO. 2; AND 1864 FOR TRACT NO. 3. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.219 CUBIC FOOT PER SECOND (CFS); BEING 0.15 CFS FOR TRACT NO. 1; 0.03 CFS FOR TRACT NO. 2; AND 0.039 CFS FOR TRACT NO. 3.
