confirms the right to use the waters of MARTIN WELL 2, within the THREEMILE CREEK BASIN for SUPPLEMENTAL IRRIGATION of 4.56 ACRES.

This right was perfected under Permit G-485. The date of priority is APRIL 4, 1955. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.04 CUBIC FOOT PER SECOND (CFS), PROVIDED FURTHER THAT THE AMOUNT OF WATER ALLOWED HEREIN, TOGETHER WITH THE AMOUNT SECURED FROM MARTIN WELL 1, SHALL NOT EXCEED 0.04 CFS OF WATER, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
