CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of MARTIN WELL 1, within the THREEMILE CREEK BASIN for IRRIGATION of 4.56 ACRES.

This right was perfected under Permit G-482. The date of priority is APRIL 16, 1947. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.04 CUBIC FOOT PER SECOND (CFS), PROVIDED FURTHER THAT THE AMOUNT OF WATER ALLOWED HEREIN, TOGETHER WITH THE AMOUNT SECURED FROM MARTIN WELL 2, SHALL NOT EXCEED 0.04 CFS OF WATER, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

1 N	13 E	WM	32	SW NE	750 FEET NORTH & 1900 FEET WEST FROM E1/4 CORNER, SECTION 32

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:


NOTICE OF RIGHT TO RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to confirm a change in place of use approved by an order of the Water Resources Director entered April 7, 2003, at Special Order Volume 57, Page 362, approving Transfer Application 8903, and correction order entered September 5, 2003, at Special Order Volume 58, Page 123, and together with Certificate 80430, supersedes Certificate 79694, State Record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
