CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of a SPRING, a tributary of PACIFIC OCEAN, for DOMESTIC USE EXPANDED FOR TWO HOUSEHOLDS.

This right was perfected under Permit 52780. The date of priority is JULY 27, 1994. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.01 CUBIC FOOT PER SECOND (cfs) or its equivalent in case of rotation measured at the point of diversion.

The point of diversion is located as follows:

Measurement, recording and reporting conditions:

- A. The Director may require the water user to install a meter or other suitable measuring device as approved by the Director. If the Director notifies the water user to install a meter or other measuring device, the water user shall install such device within the period stated in the notice. Such installation period shall not be less than 90 days unless special circumstances warrant a shorter installation period. Once installed, the water user shall maintain the meter or measuring device in good working order and shall allow the watermaster access to the meter or measuring device. The Director may provide an opportunity for the water user to submit alternative measuring procedures for approval.
- B. The Director may require the water user to keep and maintain a record of the amount (volume) of water used and may require the water user to report water use on a periodic schedule as established by the Director. In addition, the Director may require the water user to report general water use information, the periods of water use and the place and nature of use of water under the right. The Director may provide an opportunity for the water user to submit alternative reporting procedures for review and approval.

The use of water allowed herein may be made only at times when water from the unnamed spring would not otherwise flow into the Pacific Ocean or sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.

Failure to comply with any of the provisions of this right may result in action, including, but not limited to, restrictions on the use, civil penalties, or cancellation of the right

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

This certificate describes that portion of the water right confirmed by Certificate 84533, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered ________, and recorded in Special Order Volume 88, Pages 397 to 398, canceling a portion of the water right. This certificate supersedes Certificate 84533.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
