CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PERRY HOUSER
PILOT ROCK, OR 97868

confirms the right to use the waters of EAST BIRCH CREEK, a tributary of BIRCH CREEK, for IRRIGATION of 25.8 ACRES, DOMESTIC and STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 3, at Page 127. The date of priority is 1885 for 10.0 acres and 1897 for 15.8 acres.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.33 CUBIC FOOT PER SECOND, subject to the provisions of paragraph 33 of said decree and all other conditions and limitations contained in said decree.

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes that portion of the water right confirmed by Certificate 2553, State Record of Water Right Certificates, NOT transferred by the provisions of an order of the Water Resources Director entered Aug 30 2012, approving Transfer Application T-11346. The certificate also clarifies the stream to which East Birch Creek is a tributary.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
