This right was perfected under Permit G-8551. The date of priority is FEBRUARY 8, 1979. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.40 CUBIC FEET PER SECOND (CFS) IN ANY COMBINATION FROM THE WELLS AS DESCRIBED BELOW, or its equivalent in case of rotation, measured at the wells.

Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
