confirms the right to use the waters of MOUNTAIN STREAMS, tributary to END CREEK for IRRIGATION of 1.0 ACRE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Union County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 7, at Page 227. The date of priority is 1893. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.025 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

The amount of water used for irrigation is limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year, diverted at a rate of not to exceed one-fortieth of a cubic foot per second per acre. The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

A description of the place of use to which this right is appurtenant is as follows:
