CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

G AND C FARMS INC.  
4196 81ST AVE NE  
SALEM, OR 97305

confirms the right to use the waters of WELL 2 AND WELL 4 in the PUDDING RIVER BASIN for PRIMARY IRRIGATION OF 94.8 ACRES AND SUPPLEMENTAL IRRIGATION OF 96.2 ACRES.

This right was perfected under Permit G-7720. The date of priority is APRIL 8, 1977. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 2.04 CUBIC FEET PER SECOND (CFS), being 1.45 cfs from Well 2 and 0.59 cfs from Well 4, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to correct scrivener's errors in the listing of authorized wells, the rate from Well 4, the place of use for primary irrigation, and the acreage totals for primary and supplemental irrigation described on Certificate 68381. This Certificate supersedes Certificate 68381 and describes the portion of water right Certificate 53546, NOT modified by the provisions of orders of the Water Resources Director entered June 10, 1994, and recorded at Volume 48, Pages 203-208, approving Transfer Applications T-6448 and T-6449.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
