## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CHARLES J. and ESTHER E. SWIFT ROUTE 2, BOX 144 IRRIGON, OR 97844

confirms the right to use the waters of a WELL, a tributary of the COLUMBIA RIVER, for IRRIGATION of 11.98 ACRES and SUPPLEMENTAL IRRIGATION of 1.30 ACRES.

This right was perfected under Permit G-4474. The date of priority is DECEMBER 5, 1968. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.164 CUBIC FOOT PER SECOND (cfs); being 0.148 cfs for IRRIGATION and 0.016 cfs for SUPPLEMENTAL IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year; provided further that the completed well shall not exceed 400 feet in depth, nor appropriate water from an aquifer below that depth.
