CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

THE POPLARS RANCH INC. 59234 FORT ROCK RD SILVER LAKE, OR 97638

confirms the right to use the waters of A WELL in the FORT ROCK BASIN for IRRIGATION of 119.5 ACRES.

This right was perfected under Permit G-9146. The date of priority is JANUARY 9, 1981. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.49 CUBIC FEET PER SECOND, if available at the original point of appropriation located in the NW¼ SE¼ of SECTION 34, T26S, R15E, W.M.; 1450 FEET NORTH AND 1350 FEET WEST FROM THE SE CORNER OF SECTION 34; or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The following provisions shall be effective when in the judgment of the Watermaster it becomes necessary to install measuring devices:

The pump system shall include an in-line flow meter or other suitable device for measuring the water to which the user is entitled; and

The type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the measuring device be installed under the general supervision of said Watermaster.

This certificate describes that portion of the water right confirmed by Certificate 81489, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered NOV Grant approving Transfer Application T-11322.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
